



Dear Nebraska Beef Producers:

The 2018 Nebraska Beef Council Board of Director elections will be held in districts 6 and 8. To become a qualified voter in the 2018 elections, you must fill out this pre-certification affidavit.

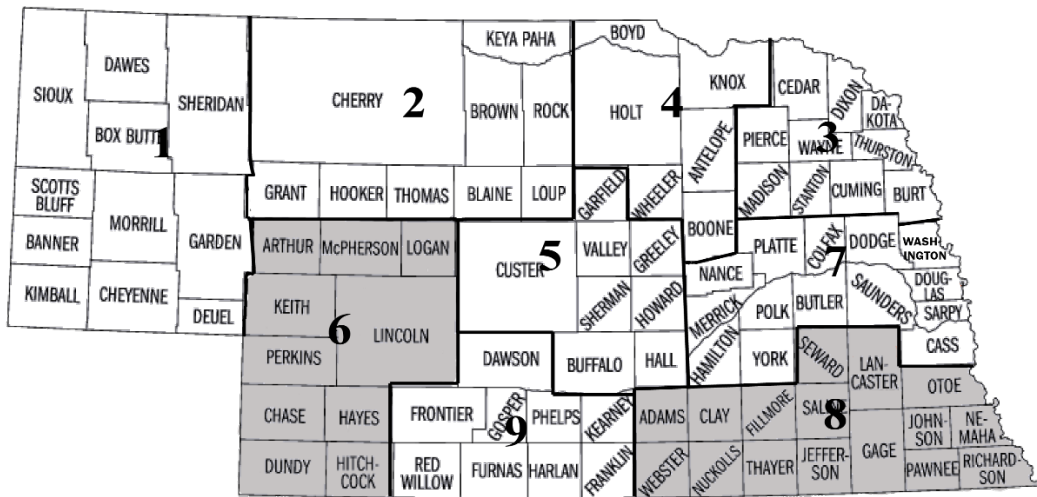
All affidavits will be verified by a third-party contractor to determine eligibility. No hand-delivered forms will be accepted. You will be notified by October 31, 2018 if it is determined you are not eligible. Voters deemed to be ineligible will have until November 9th to become eligible voters.

All qualified voters will be mailed a ballot on or before November 15, 2018. Completed ballots must be postmarked by November 30, 2018.

Important Information Regarding Voter Qualifications – Please Read Carefully

The by-laws of the Nebraska Beef Council require that each Qualified Voter sign an affidavit certifying he or she meets the following criteria. By signing this affidavit, you are certifying that you are an eligible Nebraska Beef Council voter as described below:

1. A resident of a county in the District in which an election is held (see map and listing of counties on front page).
2. A registered voter of a county in the District in which an election is held (as defined by the Statutes of the State of Nebraska).
3. A producer who may meet the requirement of owning or acquiring ownership of cattle by owning or acquiring ownership:
 - In his or her individual name that has sold cattle in 2017
 - OR is a partner in a partnership that has sold cattle in 2017 and actively participates in the operation of the partnership’s business,
 - OR is a shareholder in a corporation which sold cattle in 2017 and who, as an officer or employee of the corporation, actively participates in the operation of the corporation’s business.

NOTE: a person shall **NOT** be considered a producer if (a) the person’s only share in the proceeds of a sale of cattle or beef is a sales commission, handling fee or other service fee, or (b) the person acquired ownership of cattle to facilitate the transfer of ownership of such cattle from the seller to a third party and resold such cattle no later than ten (10) days from the date on which the person acquired ownership.
